
1. WHAT IS POOLING

- 6. We inspect, clean, repair and in worst case recycle.

3. QUALITY

As a pooling company, our load carriers need to comply with the highest technical and hygienic requirements to meet your industry standards.

Our load carriers are individually inspected after every trip to make sure they meet our Asset Quality Standard (AQS), stability and load bearing capacity are essential. This standard is available for you at your request, as well as a visit to one of our conditioning services for an on-site explanation.

In case of damages, our load carriers are repaired by our own in-house repair team to bring them back within the AQS standard.



4. LOAD CARRIERS

You can find our current product line-up on our website, but our teams are trained to understand your requirements and to support any request or question for any type of load carrier challenge you might have.

Contraload owns and controls approximately 1 million pallets and containers and more than 2 million layer pads.

5. PROCEDURES

a. POOL-IT

POOL-IT is our on-line tracking tool which you can use for placing orders, requesting collections, declaring load carriers movements or simply to pull reports on movement history and basic pooling parameters. www.pool-it.net

b. Cruise Control

We want your trip to be a smooth one, so we will continuously monitor your part of the pool and check the parameters we agreed together in the contract against what happens in real life. In case we find significant deviations, we will contact you and support you with all the information you need and send you additional reports and insights to keep you on track. We've got your back!

c. Loss Prevention

We hate lost load carriers as they need to be replaced. This requires unnecessary investments and costs and has a negative effect on the relationship with our customers. We therefore suggest to perform 4 audits per year, so we can detect potential losses, get the load carriers back in time and correct administrative mistakes.

Zero loss is our target. We also have a tailored insurance coverage in case you want an additional security.

How does an audit work?

- We agree on a date when you count the Contraload load carriers at your site.
- 2. After your count, you send us the number of load carriers you have counted.
- We double check if all declarations have been done, if trucks with load carriers were "en route", etc. so we can validate the count result against the administrative balance and establish a loss or a surplus.
- In case of a small loss or surplus, we accept the fact that this could have been a small miscount, so we can keep this difference on your stock audit result account for the next audit.
- 5. In case of a larger loss or surplus, we activate SARA... Our "Stock Audit Result Allocation" system, where we investigate the losses and surpluses of all your customers to see if your balance can be offset against the balances of your customers as a result of a possible missed or wrong declaration.
- If there are any losses left that SARA cannot trace back, we will discuss the settlement of these losses with you.

With our unique SARA system, we want to be part of the SOLUTION and work towards a loss free pooling partnership!

d. Free Consultancy

Our sales teams are experts in re-usable load carriers and by asking you the right questions about your supply chain and current packaging, they can help you select and implement the right choice of load carriers.
